Your phone call of September 22nd, 2016, at 7.45 a.m.

Dear Mister Brupbacher,

Thank you very much for your phone call which lasted 20 minutes.

You did let me know that an unwritten law normally forbids me to send copies of my open letters to the spouses of the Swiss Federal Councillors, and you invited me to stop doing so in the future.

Subsequently, we discussed about the separation of powers – state supporting for you – which, from the perspective of the judiciary victims, is a malediction of our society. See enclosed folder.

I share your concerns about a judiciary system influenced by politics. This, however, is already the case. Our actual judiciary system results from centuries of absence of any independent judiciary control over this system from the outside. This absence of checks and balances explains the decline which has reached an incredible level, not only in Switzerland. One cannot repair this lack of control through dogmas. Corruption and incompetence have plagued our judiciary system which can be remedied by politics only. Since our Swiss politicians elude their constitutional duty to watch over the judicial system, be it because of comfort or direct benefits, they should delegate that task to Historians for contemporary

History. But it would be counterproductive to mandate university-sick Law Professors, the ones who did indoctrinate you with the dogma of the separation of powers.

Dogmas were ever dumbing and degenerating people. They are no science. Common sense is essential.

*Since you did not believe that censorship is imposed in this country by secret orders, I enclose a copy of the decision of the Vaudois Prosecutor Yves Nicolet, in the meantime promoted federal Prosecutor, of September 26, 2013. At the end of page 5 the evidence is marked with a Stabiloboss. I got hold accidentally only this year of it, although said Nicolet has made his career with this dark room justice since 2007. A clerk who was not fully alert of the rules of **the illegal double file practice** has made a mishandling. You will hear more about it in due course.*

Dear Mister Brupbacher, you were not able to give me an advice, of how to tackle more efficiently the task to stop the head in the dust behaviour of the Federal Council concerning the ongoing violation of the Constitutional State. I have no desire to respect an unwritten law, known exclusively in your circles. Spouses of Federal Councillors are citizens as all others. *You appealed finally to the rules of politeness. In turn, I complain about the habit of not confirming receipt of certain Federal Councillors who I did address personally. This concerns first of all my **4 denunciations** against the corrupt and embezzling federal Judge **Roland Max Schneider**.*

Herewith I offer once more to have a clarifying conversation with a Federal Councillor or a representative. For the time being, I do not see a need to change my communication habits.
