## ***The unknown censorship of the Swiss***

*Mr Federal Councillor,*

*According to the Law of Telecommunications, it is illegal to falsify the DNS (Domain Name System of the Internet). But that is precisely practised in this country for censoring web portals considered inconvenient to your regime. The surfer who has a provider of access to Internet practising censorship, will get after a long waiting to the mendacious display: «This page cannot be displayed.» The cheated surfer will presume that this page does not exist any longer. Of course, this «blocking» - word used by your specialists to avoid the ugly term of censorship – is only realized on Swiss territory, and not perceptible beyond our borders.*

*Not only my Internet sites have been censored since 2007 by secreta and illegal procedure by the «Prosecutor» **Yves NICOLET**, who did build up successfully his career onto these manoeuvres. Here some examples of portals owned by third parties:*

*On October 5, 2016 the Vaudois «Prosecutor» **Stéphane COLETTA** ordered to 5 providers of access to Internet to «confiscate» the site [www.worldcorruption.info](http://www.worldcorruption.info) on which I am publishing since June of this year (see letter head). This time, only Swisscom/bluewin did obey to this order up to date, followed by Citycable, as their clients can check it themselves.*

*Any restriction of a fundamental right, as is the freedom of expression has to be founded on a legal basis. Serious restrictions have to be foreseen by the Law. Anyway, no regular court has ordered the censorship of this «confiscated» Internet site. In addition, the political discussion may not be hampered, and our denunciations of the judiciary dysfunctioning are without any doubt a political plea in the public interest. Therefore, this censorship is anti-constitutional, infamous.*

***Obviously your regime needs to hide stories which are not honouring our country. The obsolete dogma of the separation of powers is enhancing our politicians to be partner in judiciary crimes and corruption.***

*By **open letter of October 11, 2016** about 200 journalists and an equal number of Swiss politicians were informed of this censorship, but the Mass Media kept absolute silence, because they are censored in their turn. A journalist who would dare not to obey those orders, is risking his job. For not confessing to be cowards, they pretend that the subject is not of interest. See open letter to the Director General of the State Radio/Television **Roger DE WECK** of September 5, 2016.*

***The Swiss citizens do not have a clue to which extent they are censored and manipulated by those who are in power. They need to be enlightened from the outside of their country. This is the aim of this message, addressed in copy by e-mail to all members of the diplomatic corps in contact with our country.***
