To you, COTTIER,

Again, I address to you in your quality as a mailbox this complaint, since I have challenged all Vaudois Magistrates, including you.

Present situation in the canton of Vaud:

As a consequence, you are the stage Manager of the State Banditism in this canton. For that reason, I did challenge you and all your malefactor compagnions by registered letter of October 5, 2016. With the above indicated cases, it is irrefutably demonstrated that the Vaudois Magistrates are infected and dominated by the Freemasonry.

Denounced facts:

Passing beyond, your henchmen at the cantonal court MAILLARD, KRIEGER and PERROT did have the guts of making the bad joke to reject the mentioned challenge by abusing of their authority in an organized gang, by their decision 678 of November 21st 2016 (copy enclosed). The maneuvers of MAILLARD, KRIEGER and PERROT to cover the illegal censorship of the Web were anyway already denounced in the dossier contained in my filing of October 5, 2016, i.e. enclosure 2, published on Internet under the link:

These Judges acted in their egostic interest, by rejecting my challenge, concerning among others your person, COTTIER, for recuperating their Godfather, hoping to escape themselves the prosecution ex officio to come. In addition, KRIEGER did realize the State banditry at the costs of Werner RATHGEB. The mobile of that Trio to commit this crime was thus purely egoistic, attempting to avoid penal prosecution. Themselves challenged, they are not any longer legitimated to exercise their function, since they are unworthy and outlaws. One day, they will be made liable for their crimes.

me on October 26, 2016 (copy enclosed), and when informed by my letter of October 11th, 2016 of the challenge of all Vaudois Magistrates, including MOTTIER, she had the nerve to pretend by mail of November 16, 2016 (copy enclosed) to be entitled to proceed that way, in contradiction to any common sense. She did as well abuse of her authority in an organized gang.

Finally, I file a complaint against Jean-Yves PIDOUX, M.P. and responsible for the Internet access Provider CITYCABLE for illegal censorship of the Internet, violating article 49 of the Telecommunications Law. PIDOUX did apply the censorship of the Web Site www.worldcorruption.info (where I am presently publishing) on the only basis of an order of COLETTA, which is by no means a definitive and enforceable court decision.
