Petition of January 10, 2017

Mrs. President, Ladies and Gentlemen Members of Parliament,

In reply to this petition addressed to you, your administrative auxiliaries Igor Santucci and Cédric Aeschlimann did react by mail of 23.01.17, received on February 3rd, 2017.

Refering to a regulation dated Sept. 1st, 2016, and established by them, they invite me to present the signatures of the accused Claude BUDRY and his partner in crime Daniel KOLLY (Inspector of the criminal Police VD) declaring to agree to renounce to the protection of their coordinates. In addition, they threaten to file the petition in case that it would contain «inconvenient or insulting terms». Do you accept to be emasculated by your auxiliaries?

To use euphemisms, avoiding to identify the evil by adequate names is counterproductive. Article 16 of the Federal Constitution is prevailing (freedom of expression). The Commission of the United Nations for Human Rights has specified in 2012 that the criminalization of violations of honour is incompatible with article 19 of the international Convention concerning civil and political rights. Switzerland has signed this convention. BUDRY, having filed a penal complaint against me, may take notice.

The pursuit of the ideal of Justice is a category imperative and any pretention of administration of Justice is subject to publicity (Immanuel Kant). In the present case, the heinous crime of Claude BUDRY is obvious, covered by the judiciary apparatus of Vaud/Switzerland/Europe and all acting Vaudois Councillors of State, be it by connivance (by those of the right parties), or opportunism (by those of the left parties). This case is demonstrating that the Vaudois Magistrates are to be assimilated today to belong to a criminal organization, which did not hesitate to destroy the destiny of Jakob GUTKNECHT, condemning him wrongly for negligence – for self-ignition of his hay, 3 months after baling! I maintain my petition unchanged. After all, one cannot rely too much on you, Members of the Vaudois Parliament, fully briefed about the recurrent cases of corruption in your Canton, since many among you are taking as well profit of privileges in your turn. I call for a fund collection for informing the inhabitants of this Canton, in view of the upcoming elections.
