## **Corruption affair to the benefit of the VAUDOISE ASSURANCES**

Their departure did not empty his nursery. Béchir SEBEI, victim of a labor accident on January 22<sup>nd</sup> 2008, today disabled and materially ruined as a result of a scandalous trial performed by your brothers, has been the subject of criminal procedures. The Vaudois «Magis-rats» had the penal procedure let drag on. The general contractor of the construction site, where the accident had happened, should have activated its civil responsibility insurance (La Vaudoise Assurances).*

- 20.11.2014: Attribution of the affair to Philippe COLELOUGH.
- 08.12.2014: Called to compare as witnesses: (...) A. LASHGARI, (...)
- 11.12.2014: Received: Mail from Alireza LASHGARI, 9.12.2014, witness unavailable at the date of the audience, + enclosure. (...)  
Fax sent to the Lawyer TIÈCHE concerning the witness LASHGARI.
- 12.12.2014: Lawyer TIÈCHE is renouncing to the witness LASHGARI.  
Exemptions to appear for Alireza LASHGARI – (...)

*LASHGARI was the key witness in that affair. He had indeed booked a flight ticket on December 1<sup>st</sup> 2014. The Lawyer of SEBEI renounce to his appearance, behind the back of his client. LASHGARI has told me on May 13, 2017 that he would have indeed postponed his departure, if asked for by **COLELOUGH**.*
