*Here we go again: after our presentation, the Commission questioned separately one of the guilty persons, i.e. the Deputy Director of the Prisons of the EPO, Charles GALLEY. His version was retained, letting subsequently the Attorney General VD, **Eric COTTIER** to have the authors of this crime to benefit of the impunity.*

*This experience, to have been cheated twice by the Petition Commission is forcing me to formulate the following 2 requests in relation to the present petition, demanding the opening of a parliamentary investigation to have the serious cheatings of the Inspector KOLLY and accomplices confirmed:*

1. *Since the freemasonic plot at the costs of GUTKNECHT has been evidenced, **transparency has to be imperatively established**: Herewith I request that each Member of your Commission shall duly complete the enclosed form «Demand of Transparency», clarifying wether he/she is belonging/not belonging to a secret society.
