Your enforced placement of Jonas (today 12 years old) in a Home

To you, Christine FREITAG and your accomplices NIESSLEIN / SCHIELE etc.,

*Since the single mother of Jonas was unable to take care of him, your Office entrusted him in August 2012 to the guardianship of his Paternal grandparents. Obviously the boy felt comfortable and developed well. In March 2013 you decided to place him in July 2013 in a home. Teachers, child psychologist and pediatrician were astonished. However, the authorities never called them for a hearing. Your advise and the interests of the home industry prevailed. This error of appreciation was corroborated by the court President Anton SCHIELE and thereafter rubber-stamped by a dozen other contributors with the copy / paste method, up to the European Judge **Helen KELLER**.*

This has triggered of a citizens' protest in May 2014 in front of the Karlshalle in Ansbach (FLZ Ansbach of May 15, 2014). This did not have the slightest effect upon the authorities.

The enforced placement has seriously traumatized Jonas. He wants to go back to his grandparents. For calming him, he is forced to swallow Ritalin. Since he cannot live with the situation, he was placed into a school class for mentally handicapped children. This means that one is grafting upon your failure another heavy cock-up at the costs of Jonas.

The twelf years old Jonas has a right to be involved in the decision, if he wants to return to his grandparents – sooner or later. Admit ultimately your mistake. Better today than tomorrow.
