#### **COMPLAINT**

Mister Keller,

Since almost 5 years the State of Vaud did not make a serious attempt to repair the crime committed by its representatives, as far that this is after all still possible, that is to say the abuses

to place me by force in a nursing home and the theft/destruction of my belongings. Certainly, there were TV emissions and press articles to report about it, but no journalist had the guts to unveil the failurs of the judiciary Magistrates added after the occured abuses end of 2013 / beginning 2014. The trickery is continuing. I strongly wish to be finally heared, assisted by Gerhard Ulrich, person of my trust, by your commission, according to the petition presented on March 15, 2018. His presence is a must, since he knows my file. Or are you as well speculating me to disappear? You let me wait already since 7 months. I remind you to reach soon the age of 95 years.
