## ***The Child abduction Industry – The causes of the plague***

*To you, Anne EMERY-TORRACINTA,*

*On March 17, 2018, the Tribune de Genève reported your involvement in the sex scandal of [Tariq RAMADAN](#) in your schools in Geneva. At the International School of Geneva your husband, Pascal EMERY covered-up a serious case of mobbing and obstruction of justice. Through his letter of March 31<sup>st</sup>, 2015, he defamed the victim, a teacher, who was thereafter unjustifiably dismissed. Of course he is enjoying impunity. The penal complaints against him were simply never dealt with.*

*These last months, the Mass Media are repeatedly reporting irregularities within the Service de Protection des Mineurs (SPMI), being as well part of your dcastry. I am enclosing an open letter of the physician Angèle LÉGILLON of September 22<sup>nd</sup>, 2018 concerning this topic, sent to the President of the Commission of Human Rights of your cantonal Parliament. Initially, a hearing was planned with her, but subsequently occult powers cancelled it. That is a real pity, because the content of that letter does have an enormous public interest beyond your Republic of Geneva. This doctor is telling, how the SPMI abducted her small daughter with lies and deceits. Furthermore, this mother/physician is reporting competently, how the PSMI is malfunctioning permanently at the cost of third persons, destroying ruthlessly lives of mothers, fathers and children. This is only possible with the complicity of complacent psychiatrists and judges. The pedopsychiatrist W – the physician MENGELE of Geneva – is complacently issuing false medical*

*certificates knowingly protected by her superiors. Denounced, she was covered by a letter of the HUG of October 16, 2018, containing the vindicating sentence: «(...) that the quality of the expertises issued by the doctor W are perfectly matching the expectations requested by the mandating authorities.» Who pays commands. One does not care about the destiny of the appraised people. The Tribunal de Protection de l'Adulte et de l'Enfant (TPAE) is than taking over. The «Judge» B does not even need to get to know the mother, to whom she will cut the contacts with her baby! Example: her order of April 9, 2018 at the costs of Dr LÉGILLON and her baby. – Madame EMERY-TORRACINTA, there are too many mistakes accumulating under your watch. One is legitimate in asking whether you are not the problem, preventing a total reform of the whole system.*

*The child abduction Industry is flourishing as well in our neighbouring countries, exactly according to the same pattern as that one described by Dr LÉGILLON. In Germany, 84'000 children are kidnapped per year (2016). This is creating a market of 5 billions Euros/vintage (84'000 x Euros 60'000), which ought to be multiplied by the average number of years, during which the children are kept as hostages. The turnover of that Industry amounts probably to 50 billions of Euros (the yield of 10 years). Among others, the German activist Heiderose MANTHEY is denouncing vigorously these atrocities: <http://archezeit.net/>*

*The plague is raging throughout the western world. Where shall we search for the causes? Europe does have the heritage of fascism, which was promoting child rearing by the State, as is the case in Switzerland. The victims of the Authorities of the Protection of the Child (/APEA) and the Adult did succeed the former contract children, but the mentality remained unchanged. To Whom it May Concern

Albert Einstein said, 'Never **do anything** against **conscience even if the state** demands it.'

Having conducted my 'maturité' research on Nazi physicians, it is clear that some physicians are still practicing in accordance with that same mentality. Instead of being gassed to death, people are being destroyed psychologically. My allegations may be serious. However, the time has come to let the population know what is going on in this country.

Switzerland has a history of abusive placement of children, at the time within religious prominence ; it seems that history is repeating itself and my conscience as a physician, citizen and mother is inciting me to facilitate change. I cannot remain insensitive, albeit certain people are mighty and protected. Hundreds of families are concerned in Geneva, as well as in other Cantons.

It must be said that I was subjected, as a teenager, to the measures of the 'Service de Protection des Mineurs'(SPMI) for financial reasons, and the stakeholders did strongly advise against my studying medicine because of the lack of family support I had living with my old sick grandmother. However, I had been amongst the highfliers of the class, presenting no troubles whatsoever. But when I left their offices, I felt desparate. They lost ... I got my diploma in 2012 in Geneva, and I financed my studies myself. They won temporarily again, as this same body is now separating me from my daughter ... life seems to be a struggle, and being a pacifist, I could have done without this.

After a short career as a physician I thought, naively, that I knew a lot about pain. I saw dead bodies, victims of rape, mobbing and assassinations. Myself and other victims of the SPMI, united months ago, are suffering beyond what I had thought possible. Deprived of our children, ruined by judiciary fees, obliged to consult psychiatrists, we ask ourselves regularly how such things can occur in a country like Switzerland and how fundamental rights of children can be violated in full impunity.

I start thus with my own story. I have had enormous concerns about the SPMI for almost two years.

I am a 34 years old mother from Geneva, having had a marvellous little girl, born in May 2015. I opted to foster her alone, but I wished to give rights to her father.

Having decided to breast-feed for as long as possible, since being a physician, I think that breast-feeding should be encouraged, and after 6 months of maternity leave without problems (witnessed by my extraordinary midwife and pediatrician, both certifying the normal development of the baby), I resumed work at the HUG (Hôpital Universitaire Genevois) - It ought to be mentioned, unfortunately, in a stretched service (in psychiatry, at the Cappi of the Eaux-Vives, Geneva). Other physicians complained. If I am not mistaken, according to my knowledge, there were burnouts and work disruptions. The Cappi at the Pâquis was about to be closed down, and there was a lot of stress and an influx of patients.

I point out that I had previously been an emergency doctor. After great consideration, I had chosen to retrain to become a generalist physician, in a country where such specialists are really lacking, in order to have more stable working schedules, and to practice for one year in psychiatry, since this is actively encouraged in the study cycles of general medicine.

I was repeatedly subjected to harassment from my mother-in-law, the former nurse of my aunt. They had been friends for years. The reason was that I wanted to get my daughter out of the creche and placed with a day mother, also taking care of other children. Not only was the creche expensive, but the working schedule was incompatible with my service hours and working. This harassment led me to a state of exhaustion in the context of me resuming work at the HUG.

I could not permit a patient to be put at risk, as I could not permit myself to be blamed for assuming the responsibilities related to the job of a doctor. I emphasize that I never arrived late at the creche. I point out as well that I consider to have done the best I possibly could to be a good physician, listening to my patients.

Two women wrote a letter to the pediatrician, saying that the daily care of my girl was managed poorly by me, making false accusations (pretending that they had to do my shopping and my administrative work). As a matter of fact, nobody has ever helped me to do my shopping. It must also be said that my midwife was surprised by the lack of support I got. At that time, I had no financial concerns, no reminders nor bad debt prosecutions, although life was not easy (salary as an internal doctor at 80 %, horrendous flat rental costs in Geneva, creche expenses of 1'200 francs, health insurance ...).

I was obliged to cancel my inscription to the FMH internal medicine examination in 2016, since the two women had blamed my studies ! I was fed up and applied for a job in the Canton of Vaud to get away from these people. I suppose that this triggered their fear

of not seeing my child any more. But contrary to their behaviour, I would never have cut contact or phone calls.

Confronted with such hatred, and because my mother in law and the father of my child repeatedly called the police, the police officers could only confirm to have seen a mother and her baby doing well, I ended up breaking down in tears at the creche. After all I am a human being. The administrative director, Mr. Bruon Domergue denounced my case to the SPMI, and from one day to another, my guardianship of my daughter was removed in July 2016, threatening me to have her placed in a home, if I tried to come close to her (jeopardy clause). There existed no evidence of negligence or abuse, for the baby developed normally, and I was providing for her. I even have a recording of the father of the child saying that I was not a danger for Clara, but he had to comply as the SPMI was ordering it - otherwise, it would result in her placement in a home. Personally, I do not have negative intentions towards her father. I presume he obeyed orders without choice, and I am not at war with him. I just wished to establish peaceful communications for the wellbeing of our child. I was informed recently that, following a petition launched by various parents, Mr. Bruno Domergue has been fired. I had a minor disagreement with him, since the creche had refused to take care of my baby without antibiotics for her eyes. However, she did not suffer from conjunctivitis but a slight irritation because of her long eyelashes... I consider this it to be absurd nowadays that creche assistants are diagnosing conjunctivitis ! Even the pediatrician of Clara felt it inappropriate.

I had to struggle during the whole summer of 2016 (the assistants of the SPMI having been on holidays) to see my child, who I did not see or hear on the phone for months, to find a lawyer, to see her finally under supervision, and to take her to my home only every second weekend. It goes without saying that under those conditions, I was on sick leave due to sadness, and from preparing a substantive file for the court audience, with witness testimonies of my friends, most of them physicians.

I learned at the beginning of that summer that the human resources department at the HUG had transferred me to the emergency psychiatry unit at Belle-Idée (psychiatric hospital). I refused this transfer. One of my family members had been repeatedly hospitalized and had requested their services, so there was thus a conflict of interests. Meanwhile, my daughter was moved from one creche to another one, without informing me, but allegedly with my agreement and signature according to the files of the SPMI. After several visits under supervision, I managed however to regain the right of visit every second weekend.

Unfortunately, one of these weekends was shortened, because of a medical emergency case which I reported, but which the court blamed me for. One weekend, I went up to the mountains with my child, accompanied by physician friends. Immediately thereafter, I was accused of having returned her exhausted, dirty and late.... Of course, I provided evidence of photographs of my daughter, smiling and radiant – to no avail. It is always the same pattern: one of the parents is selected to be the target, and the other one is pitted against them.

A first audience was fixed finally for December 2016, but the judge fell sick and the hearing was postponed to January 2017. That was my first working week. ... Again, I was blamed by the social assistant of the SPMI for postponing the audience, before acknowledging that the judge had, in fact, been absent. The audience in January 2017, during my first working week, was a nightmare; the judge took the side of the father of the child, requested me to undergo a psychiatric expertise, believing apparently his false allegations (allegedly, I had aggressed and almost disfigured him – the whole accusation without any evidence or medical attestations). How is it possible that judges believe such accusations?

I resumed work in January 2017 at the emergency cabinet in a private hospital, with working hours which were not respecting all the conditions of the SPMI and the father of the child. Unfortunately, I was assigned to weekend and night services, incompatible with the schedule fixed by the judge. In agreement with my employer, he did not renew the probation period. In addition, the SPMI fixed appointments during the week. And according to the justice, I needed to see a psychiatrist....

I thus accepted a hospitalization at Crans-Montana in March 2017. I left one week later, since I do not have a health insurance covering private care, causing emotional stress that promptly resulted in further accusations by the SPMI. And that way, I did not see my young daughter from January until June 2017, i.e. 6 ½ months, being allegedly a potential danger. I authorized the physicians at the hospital to call the social assistant. I stayed there one week without any treatment. I am not sick, but me and my child are just victims of an enormous injustice.

Immediately thereafter I found another job in the insurance industry, promising to be more compatible with the ongoing judiciary procedures. Nothing to do – my employer became aware of my personal situation and my trial period was not extended.... because of the psychiatric expertise at the HUG with its appointments during the week ... I want to say as well that I did not see, hear or obtain any news of my daughter, less than two years old – between January 31<sup>st</sup>, 2016 and June 2017... I saw her once at the meeting point, and another time in the office of the psychiatric expert....

The social assistant in charge of the file, a 54 years old international commuter who spends most of the time on sick leave (once almost six months, without any replacement) criticized my flat, my religious values, saying that for the sake of the wellbeing of my baby, she should under no circumstances be connected with me by phone, as well as other absurd things. I do not hate her personally, since I guess that the staff members of the SPMI are just following orders, to keep their jobs.

I asked several times to have the curator changed. Among others, I submitted my demand to the two secretaries of Mrs. Torracinta (State Councillor of Geneva), but I never succeeded. I mandated mediators, but the child's father refused. I did everything possible to achieve a settlement out of the absurd situation.

For two years, inspite of me having the parental authority actually withdrawn from April 2018, it is even impossible to have a discussion with the pediatrician, according to the

instructions imposed by the SPMI. I do not even know if the vaccinations of my daughter have been updated, or if she is suffering from allergies.

Aware that the working hours of an intra-hospital physician are not compatible with the conditions of the SPMI having turned against me, I tried to retrain to become a therapist by undergoing a training, which was also not approved by the SPMI. They stated that I did not want to maintain the contact with my daughter, and that I was psychologically unstable.

I was beginning a replacement in 2018 in a medical office, and life brought me into contact with other parents, exhausted and ruined by the SPMI, and victims of the same psychiatric expert. I felt so powerless ... What to say to them, how to cure them?

Having no right to unemployment indemnities for incomprehensible reasons, I ended up at the hospice général.

The only people I actually meet are victims of the SPMI, most of them having undergone an expertise by Doctor W, the expert mandated by the TPAE (Tribunal de Protection de l'Adulte et de l'Enfant). We have all been labelled as having troubles of personality, to be 'paranoid,' 'narcissistic,' and myself to have 'undetermined troubles of personality.'

My generalist physician since I was 20 presented a certificate attesting that I never had mental disorders nor had I taken psychotropic treatments.

Through my contact with these people, I have learned more about psychology and medicine than during my years of hospital work. These exhausted parents have passed through all the stages of human distress. As I have. There are good reasons for it. We are treated like criminals.

As a physician, I have witnessed the consequences of the SPMI taking charge in a great number of cases. I never expected to have this experience myself... All parents end up ruined, exhausted, losing their jobs and living in shame. For several months articles in the newspapers of Geneva are reporting numerous dysfunctions of this service (see as well the many articles about the dismissal of directors of the SPMI Geneva).

We get all sick. This is challenging everything I have learned about medicine. All these mothers suffer repeated bouts of cystitis. How much does that cost society, and what is the price for humanity?

Why does this service impose requests which are incompatible with the pace of a 'normal' life and why do they tear apart families instead of mandating mediators ?

In April 2018 I received the report of a judge of the court, whom I have never met, informing me that my parental authority had been withdrawn as a result of not having shown up for meetings since December 2017 as well as being unemployed. Even my visiting rights under surveillance were cancelled. I was charged as well because I am no longer seeing the psychiatrist. I can tell you that I have photographs taken at that place in January, February, March and April, and a witness has even written a letter testifying that I turned up at the meeting point... As usual, the mails of the SPMI are lying.

This is my story ... and that of little Clara, who does not deserve all that, as no child deserves it at all.

A girlfriend, Manuela Afonso, a former work colleague at the HUG also had to suffer such a psychiatric expertise. Her wonderful twin daughters, were trembling with fear, urinating on themselves, when facing the doctor W in order not to have a compromised future. According to the resulting report, they risk being torn away from their mother, said to be loving them too much, to be entrusted to their violent father. Several documents are evidencing this. Even the expertises realized by the doctors Goulaz and Walter are mentioning the violence of the father. How does it conclude, nevertheless, transferring the guardianship to that father ? I wish to witness as a friend, mother and physician, having had the chance to share moments of leisure and holidays with my girlfriend and her daughters. I never observed any suspicious gestures which would have justified having this mother alienated from her children. She even gave the phone to the girls to chat with their father, whereas the reports of the SPMI are pretending that she wants to cut the children off from him.... One does not listen to the children, one is not listening the witnesses, and that is a real pity.

Last week, I met another victim. Her four teenagers have been placed in a home for four years. One of them was stricken by a rare genetical illness and does not get the appropriate care, according to his health problem. He almost lost one of his legs because of an infection. He is poorly taken care of in the home, and there is a refusal to even call for emergency medical assistance... One needs a strong stomach to listen to these youngsters ... Again I have had the chance to share moments of private life with these young people. I say it without any pretention. I am ignoring the diagnosis made by the expertise of the doctor W. These youngsters are broken and say they are ashamed to be Swiss, and I guess that this can be understood. I think every day how to obtain the means to get them out from there, in order to obtain adequate care. This affair is dragging on, although it has been reported by the media.

Another of my friends is actually in a precarious situation. He is now been struggling for more than a year to evidence that the mother, who has guardianship thanks to the SPMI, is possibly abusing and neglecting their son (he has been taken at the age of 17 months to the pediatric emergency unit, due to second and third degree burns on



his face and right shoulder, that the mother could not offer an explanation for. After having dropped the child at the hospital, she left him alone there.

Mister Pedro Texeira had suffered a hemorrhagic stroke, which was medically attested to on July 5, 2017, with the consequential aftermath, as a result of the stress caused by the interrogations by the SPMI, as well as their refusal to face reality. He underwent a psychiatric expertise after being threatened the day after the diagnosis of the stroke, suffering from serious walking disorders, established by the expert. He had however phoned the service of forensic medicine of the HUG, alerting the internal physician surveyed by the doctor Walter, explaining his health state. That physician answered that he would be missing the appointment of the expertise, and that he might never see his son again.

He was thus taken to the expertise in a very critical shape. His life prognosis was potentially threatened. Any physician knows that in a period of an acute stroke, one ought to monitor certain parameters, such as blood pressure. This patient should have been in a monitored unit, and not exposed to an additional stress, which could have aggravated his case.

The medical reports and graphs in my possession, and the documents managed by his lawyer dated the same week evidence that this patient had a severe somatic pathology. He even showed the cerebral graphics to the internal physician, responsible for a part of the expertise. Mr. Teixeira faced the diagnosis of narcissistic troubles of his personality after two sessions, one with an internal doctor and another one with doctor W. However, according to the DSM it is impossible to realize such a diagnosis, when a somatic disease – in his case neurological – may better explain the symptoms.

Thanks to his lawyers ... It is a miracle that he is still alive. It was easier to diagnose him as having a narcissic problem, and to probably be an alcoholic, in seeing his his ataxic gait – even if it had been caused by a cerebral stroke. Today, he is the victim of failed care and management of his stroke and being permanently exposed to the stress. Ruined, Mr. Teixeira is regularly presenting hyper blood pressure, headaches, and is prohibited from seeing his three years old son. With the help of his lawyer, he filed a complaint against the doctor Walter. Henceforward, he was threatened by the SPMI and a decision dated August 10, 2018 issued by the TPAE, prohibited him from seeing his son, even under surveillance, as a result of the false declarations of the SPMI, stating that there was a risk of child abduction during a surveyed appointment.

I have not seen my daughter since April 14, 2018. I saw her from June 2017 at the meeting point for 3 hours per month. The SPMI dared to write that I had been occasionally late, albeit that the father of the child or his family had been late. I do not trust anymore the interveners at that place.

Jointly with several parents, we deposited our files and expertises with a lawyer. According to our informations and a press article published on May 4, 2018, an investigation is underway. We pray everyday that transparency is achieved...

At the beginning of summer, the meeting point was transferred to a sordid place, according to other parents, in the quarter of the Charmilles. I do not wish that my daughter and myself visit that place. In addition, a meeting of 1 hour and 30 minutes on Saturday afternoons has been imposed on me, every second weekend. It is not permitted to miss in one single appointment.

I decided to do a complementary training in hypnosis, to be able to assist more effectively my patients. It is well known that doctors ought to train themselves continuously, and unfortunately, such trainings are scheduled usually during weekends. The Judges of the TPAE accused me of being an egoist ! It has to be understood, that I dream of seeing Clara. But not in that place, where the risk of invented lies against me is prevailing (example: the SPMI has said in their reports that I had threatened them etc.). And how is it possible in 2018 to blame a woman for trying to develop herself and to carry out her job correctly? Like my friend Pedro, who was at the meeting point, I am frightened as well, that they will imagine again so called threats of kidnapping my child or the like.

I do not have any news of her. I ignore even where she is living. Having been unable to pay my taxes for two years, and being crippled with debts for two years, TPAE has requested that a possible guardianship be imposed on me. One has to know that my daughter has two health insurances, and I am not able to resolve that problem, since the parental authority was removed from me... One can be easily prosecuted and multi-endebted. I did not pay three months of creche, having been advised by my lawyer to do so. And there we go. I have, for the first time, been prosecuted for debts... This makes it impossible to move and to find a smaller flat, corresponding to my budget. Hence, the pursuit of a medical career and obtaining the title of specialist is very expensive.

I have, thus, the choice between the anguish of what will happen with my daughter and the lack of money, the threat of being expelled from my flat because of unpaid rent, as well as various appointments, attempting to avoid being put under the stress of guardianship. I am actively seeking a job which is not too stressful because of all of what has happened to me during the past two years. But evidently, I do not wish to remain dependant on social assistance. I want to manage my life and take care of people's health, and of course, I want to recover my daughter. And I am dreaming that justice will be restored in our stories, as well as in the name of all those children who are suffering from parental alienation, and not seeing their parents in real life.

With these lines I have reported some of our stories. It is high time to reform this service. In a country such as Switzerland, we do have the means to help parents avoid at all costs that children have to pay the price for conflicts between adults, amplified by the absurd directives of the SPMI. Certain of these children are exposed to dangers in the homes, where they do not get correct care.
