**No public and no contradictory hearing concerning  
[Rita ROSENSTIEL](#) (94)**

Mr. COURDESSE,

By letter of December 4, 2018, you communicated your very democratic desire to run this hearing behind closed doors. You are refusing public and contradictory debates. You imposed to me a deadline, reached on December 10, 2018 for confirming that Mrs. [ROSENSTIEL](#) will appear alone in my company on the site of the Parliament. I bow to your need to act behind closed doors, since you are graciously offering «**the opportunity to present quietly and serenely**» our petitions. To my knowledge, only the petition in favour of [Rita ROSENSTIEL](#) will be discussed.

I come back to my proposal to have the hearing at least audio recorded. There exists no valid argument against it.

You are exempting Messr [MAILLARD](#), [KALTENRIEDER](#) and [COTTIER](#) to appear. They are reading me in copy. From our side, we do not exempt them from responding to the allegations and questions presented individually to them by registered mail of November 22, 2018. Without motivated reply from their side,

*the allegations contained in these questionnaires will have to be considered uncontested.*

*The only one who did react to the invitation to appear is your Zampano of Justice, **COTTIER**. He is honouring me from time to time with his prose. He has mailed to me on March 16, 2018 a registered letter, using a faecal language. (*enclosure 1*). This lack of sophistication is possibly due to the fact that he never has managed to pass a bar exam. This minor detail did not prevent you to elect him as your Attorney General. His letter of December 5, 2018 is sarcastic and threatening, but at least, there do not exist unacceptable expressions (*enclosure 2*).*

*I am exploiting the opportunity to inform you that the abuses at the costs of **Rita ROSENSTIEL** are continueing. The last dirty trick of the female trustee was to finance the hearing aids which here pupil is needing with her account «moral wrongs», of course with the approval of the Judge of peace LOICHAT MIRA, instead of activating the old pension security to assume these expenses. This laziness to act without prior discussiion with the person, concerned in the first place, is border mismanagement.*

*We shall appear on January 23, 2019 according to your diktat alone before your Commission, without exagorate hope that you shall end this disgusting and brutal carelessness committed by the representatives of the State on the back of senior persons.*
