Denunciation for mismanagement, misappropriation and abuse of trust committed ex officio at the costs of Rita ROSENSTIEL (95 years old) www.worldcorruption.info/eng/rosenstiel.htm

To you, Eric COTTIER,

In January 2014, Rita ROSENSTIEL was forced into a home. The designated trustee has stolen and destroyed all her belongings. He has established a falsified inventory, overshadowing the existence of the household at the beginning of his mandate. This made it possible to the State of Vaud to evade paying an idemnity for the material loss (furniture insured for CHF 80'000). With the help of an unfair Lawyer her complaints were not treated. Exhausted / weakened and constrained by her unfair Lawyer, she signed 3 ½ years later a transaction against her interests: withdrawal of her complaints against the payement of CHF 20'000 for moral wrongs as a final settlement.

The CHF 20'000 were transfered on July 20, 2017 on the account S 5416.49.68 CHF CO CLASSIQUE at the BCV. On July 26, 2019, the Office of curatorship sucked away CHF 19'000. After long resistance, the Office finally gave in to the requests of Rita ROSENSTIEL on February 13, 2019 to establish transparency concerning the disappeared money. On August 4, 2017, CHF 10'000 were transfered to the current account 1020, and CHF 9'000 remained on the account 1055, designated as «account moral wrongs». This is clearly a misappropriation, since the received amount for moral wrongs is inalinéable and indivisible.

On March 31.03.19 the «current account 1020» had a remainder of CHF 3'522 (enclosure 5). Rita ROSENSTIEL is recognizing only expenses for CHF 3'026.65 (according to her letter to the Office of February 14, 2019 – enclosure 2) + CHF

200 reveived in March 2019, thus a total of 3'226.65. The credit amounts subsequently to CHF 10'000 - 3'226.65 = 6'773.35 + CHF 9'000 = CHF 15'773.35 totally, placed on a single and distinct account for moral wrongs. The concerned person is contesting the informal decision of the Office, dated March 21^{st} , 2019 (enclosure 3):

- 1. CHF 2'400 for hearing aids. This invoice has been charged without enforceable judiciary decision. The appeal of Mrs. ROSENSTIEL of December 10, 2018 to the cantonal court is still in suspense (enclosure 4). According to the hosting agreement with the retirement home, they are probably liable in case of loss.
- 2. CHF 3'100 withdrawn for judiciary fees, out of which CHF 2'400 for the fees of her unfair Lawyer! This is the height of cynisme.

Everything was done behind the back of the victim. And it is ongoing: The Office is obstructing that Rita ROSENSTIEL could benefit of the obtained lump sum for moral wrongs by any kinds of chicanes. See her complaint adderessed today at the Office (enclosure 5). One is aiming obviously the biological solution: in the case of passing away, the State of Vaud will recuperate the biggest part of the sum payed out for moral wrongs, being the heir of this senior Lady without parents. These manoeuvers constitute as well the offence of mismanagement, of misappropriation and abuse of trust — denunciation against unknown persons.

A citizens' jury did condemn you on January 2019, together with the President of the cantonal court KALTENRIEDER and the State Councillor MAILLARD for corruption in the plot at the costs of Mrs. ROSENSTIEL. Of course, this denunciation will be rejected by your mafia. I do not have another option: denouncing the plot, addressed to Nicoletta DELLA VALLE, FedPOL on February 18, 2019 (enclosure 6) she recommended on March 12, 2019 (enclosrure 7) «to address yourself to the judiciary authorities of your Canton». A joke.

This action is aiming to inform my readers throughout Europe of your ill treatment of the respectable more than ninety years old Rita ROSENSTIEL, which will sentence you.

Protest against your chicaneries - Request to take profit of my «account Moral Wrongs» during my lifetime

Ladies and Gentlemen,

On April 1st, 2019, my current account at the Office of the home Nelty de Beausobre amounted to CHF 705.65. The sum was composed of 2 monthly contributions of CHF 250 + CHF 200 which you had transferred from your «currant account 1020 », in reply to my demand of March 12, 2019 for covering expenses for the hair dresser and stamps.

However, you instructed the home, once again behind my back not to pay out more than CHF 250.-/month. I got informed that I am the only resident having this discriminating measure.

My account for Moral Wrongs (CHF 20'000 payed out by the State of Vaud for the suffered crimes), which should contain today still CHF 15'773.35 according to our calculations, is managed arbitrarily by you. Yes, you did finance the printing of my autobiography for a total amount of CHF 2'496.25. For the rest, you treated me miserliness. Only with the support of Gerhard Ulrich I managed during the last months to obtain a total sum of CHF 705.65 for covering various

expenses. With your ceiling to pay out monthly just CHF 250.- at the desk of the home, even these concessions do not benefit me.

The idemnity for Moral Wrongs suffered is inalienable. However, you diverted money behind my back. A denunciation for mismanagement, misappropriation and abuse of trust is pending.

The only objective of your greed is that the State of Vaud will recover the great part of the CHF 20'000 payed out for Moral Wrongs. Having no parents, the Canton of Vaud will benefit this way from this inheritance.

The way you treat me as your object is scandalous.

Herewith, I request you to pay me out with immediat effect monthly CHF 300 from my account for Moral Wrongs, in addition to the usual monthly contributions of CHF 250. Please issue a formal decision.
