- Martin DE MURALT, actual Commander of the Police Région de Morges***

*To you, Eric COTTIER,*

*You certainly remember the theft of our advertising convoy on April 5, 2017 by your supercops in Morges, denouncing the Freemasonry during the last Vaudois election campaign. For refreshing your souvenirs, please consult the URL:*

*Because of this repression of the right of freedom of expression, the Canton of Vaud does not have actually legally elected Members of Parliament nor State Councillors. Exactly this crowd did reelect you, since your corruption is benefiting them. You and the accused Police Officers, you are just the pawns of the occult powers.*

*This convoy has been regularly stationed from March 30, 2017 onwards on a parcel belonging to the Commune of Morges, at the exit of Morges to the right of the avenue Muret. This convoy has been stolen in the afternoon of April 5, 2017.*

*Marc-Etienne BURDET submitted the following day a penal complaint for various law violations ([enclosure 1](#)) – **complaint never dealt with!***

*By contrast, the former Commander of the Police Région de Morges, with the complicity of his successor and the Commander of the Gendarmerie vaudoise charged me with a fine of CHF 280.- for violation of the traffic law, which I had not committed, since the convoy was stationed on a spot, where cars are stationed up to date, and these drivers are never fined. *Now, your zealous cops announced me by letter of April 23, 2019 that this illegal unpaid fine shall be converted into a prison sentence ([enclosure 2](#)).*

*This is the world turned upside down. I am guilty of nothing. On the other hand, the maneuvers of your mentioned subservients are constituting attacks against the Constitutional Order. The absurdity of the contradiction is obvious.*

*In the present case, you will have to investigate against yourself. As a reliable brother you are certainly part of the plot. Up to you to challenge yourself spontaneously. It is sad that I do not have another choice than to address this complaint to you. Such a complaint sent to the Prosecutor's Office of the Swiss Confederation would be returned with the stereotypical haranguing of your Bernese Partners in crime that you are competent to deal with it.*
