

## Request for political asylum in the USA

Dear Mr. President,

I grew up in a patriotically-minded Swiss farmer family. Until I was 55 years old, I led the life of a good citizen until I discovered the tyranny of justice in 2000. I became a dissident. Because of my criticism of judges and lawyers, I have already been sentenced to 4 years in prison for alleged defamation, i.e. for suppressing freedom of expression.

After my release in 2014, I resumed the struggle against the judicial disaster and I am now to be imprisoned again as a political prisoner in September 2020.

After 20 years of persistent research, I have been able to prove that no international body enforces human rights. Both the European Court of Human

Rights and the United Nations High Commissioner for Human Rights have been infiltrated by the Deep State and are not fulfilling their role at all.

The Corona Plandemic made me aware that the globalists fought by President Donald Trump are, after all, also the ones who are causing the catastrophy of the European judicial system.

I therefore take the liberty of requesting political asylum from the United States of America, as my basic rights under the United Nations Universal Declaration of Human Rights of December 10, 1948 are being grossly violated by Switzerland, in particular Article 19 (right to freedom of expression).

If my request is granted, it would be my wish to be allowed to settle down at the USA base in Ramstein / Germany, since I intend to continue my contribution to the drying up of the swamp here in Europe.

On August 18, 2020 I was turned down with an identical asylum application at your US Embassy in Bern. An official with the first name Scott referred me to the UNHCR. However, my experience with the OHCHR has given me the certainty that it is impossible to file a complaint with a UN agency. In the enclosure I submit the evidence.

Certain people in your US Embassy are therefore either naive or members of the deep state. However, I have no idea whether your Ambassador Edward McMullen has even seen my application.

Therefore I feel compelled to try to address you directly.
