Request of reconsideration

This decision has been taken by the Federal «Judges» Thomas MERKLI, Ivo EUSEBIO and François CHAIX, each-one heavily noticed in our data base:

As all Federal Judges, they are recidivists in judiciary fraud. Let's point out that we know less than 1 % of their cheatings. There is thus no surprise that those individuals did reject my recourse of 21.12.16 in a record time of only 10 days, in spite of the holidays of end of the year, since they risk to be sanctioned one day for their own misdeeds. Incidentally, they have treated as well my request of challenge of all Federal «Judges», motivated by my actions of 23.11.23 and 18.12.16 concerning their former corrupt and frauding colleague Max Roland SCHNEIDER. To be Judge and party is inconceivable.

MERKLI and partners in crime claim that I did not indicate in my recourse the facts which are charging the former Federal «Judge» SCHNEIDER, whereas the whole world can check it by consulting the given link

According to them, I should have provided hard copies — as I have done it so many times in the past. They would have been returned to me for keeping the archives on Mon Repos «clean» (= falsification of History). The plausibility test for the guilt of **SCHNEIDER** has been carried out a long time ago by the Dark Room of the Nation itself:

In the framework of the federal penal procedure URA VU.2004.48, triggered off without success by 8 Federal «Judges» against the undersigned, the Office of the federal investigating Judges summoned in 2005 the architect Erhard KELLER as a person for information. He confirmed point by point the correctness of my denunciations against SCHNEIDER. Since this witnessing was undesirable, it was hidden away in a parallel file, leaving no traces in the file URA VU.2004.48. Needless to say that such methods are heavily violating the Law.

For this reason I submit this request for reconsideration with the claim to abolish simply the ATF 1B_484/2016 of Jan. 11, 2017 (encl. 1). I add the corpus delicti, i.e. the letter of the Zurich insurance company of Oct. 20, 2001, confirming to have paid out to SCHNEIDER on Sept. 15, 1992 CHF 390'000 (encl. 2), whereas his cronies at the Federal Court, ignoring that fact, including a certain MERKLI had allocated to him by ATF 4C.118/1998 of June 27, 2000 only the sum of CHF 93'694, of which the unpaid architect fee of CHF 19'562 had to be deducted (encl. 3).

These fees have never been payed = fraud committed by **SCHNEIDER**. The difference between CHF 390'000 and 93'694 is bribery money payed out to **SCHNEIDER**.

These are not at all new means of evidences, since they were produced again and again in the past to the authorities as hard copies. In addition, the complete file of **SCHNEIDER** is published on the Web. For a check, the authorities can just call his victim, the architect KELLER on his Handy 079 874 35 50.

This request is addressed to you as well in your quality as a letter box, since you too do have a lively interest to violate the Law by ignoring the corpus delicti and my challenge of all Federal Judges.
