**APPEAL TO THE PEOPLE wants to cancel its condemnations** Your report of February 25, 2017

Dear Mr. ZOELLIG,

Your wrote that APPEAL TO THE PEOPLE had struggled by hitting with flyers and **stalking** the Magistrates for (pretended) «corruption» of the Swiss judiciary system. I ignore where the investigative journalist ZOELLIG has found that this association of judiciary victims, known for its non-violence would have been condemned for stalking (a particular form of constraint).

At the time, you did publish reports about the 3 trials triggered off against our activists between 2003 and 2006 in Fribourg. On December 23, 2006, La Liberté, followed by La Gruyère announced that the cantonal court of Fribourg had cancelled the condemnations pronounced by the court of the Sarine. All the cheating for setting that scene by your honourable Magistrates was nothing else than an anti-constitutional and unpunished repression of the freedom of expression. – For what concerns the show trials in 2006 and 2007 in the Canton of Vaud, see

However, it is true that 8 Federal Judges had denounced me in 2004 for constraint / stalking against their persons. But after 6 years of «investigations» the penal Federal Court in Bellinzona was forced to acquit me in 2010:

This is demonstrating their professional level. Enclosed, I send you as promised the book of Jacques SECRETAN L'affaire Légeret – Un assassin imaginaire (Editor Mon Village, 2016), as well as 3 of my books on USB stick:

- The judiciary crime at the costs of François Légeret or The Album of Dishonour
- Bitter Pill for the Freemasons (only 41 pages) published on \_ www.worldcorruption.info/eng/gutknecht.htm The first 3 titles are furnishing to the investigating journalist as you are the evidence, that François LÉGERET and Laurent SÉGALAT were wrongly condemned to long prison sentences. Since the Vaudois/Swiss Magistrates were thus informed about these «errors» and are not correcting them, these injustices became intentional. We are faced with the judiciary crime.

During our meeting of February 24, 2017, you said not to believe in «the theory of the freemason plot ». I can follow you on that point. I did need 16 years of research and analysis before proving the existence of that hidden power by a concrete case. Only when publishing my 6th book (Bitter Pill for the Freemasons) on November 4, 2016 I joined Marc-Etienne BURDET in his conviction about the reality of the masonic plot. It has to be pointed out that I was fixed primarily on the condemnations based on convictions instead of evidences (rather seldom). In turn, BURDET's priority were property infringements related to corruption. This is explaining, why he discovered more rapidly the conflicts of interests.

Anyway, by circular letter of June 3, 2016, I did serve on a silver platter the names of 7 victims of corruption, of which 6 with their cellular phone numbers:
